#### General Advocacy and Key Messages

#### (SENSITIZE)

#### The Importance of Education

Education is a right: The right to free and compulsory schooling for everyone (regardless of gender, nationality, refugee status, economic status, physical ability, etc.) is enshrined in international and national laws. It is important that education continues under any condition (at school, at home, education everywhere). Education is essential for all children (girls and boys) regardless of the duration a family thinks it may stay in Türkiye or family members' physical, intellectual or language abilities.

Education plays a critical role in supporting the developmental needs of children. Schools provide important opportunities for children to learn, socialize, make friends, play and lead normal lives. The daily routine of going to school has been shown to have important emotional and psychosocial benefits for children.

Enrolling in and remaining in education supports individuals' and families' future prosperity. Research shows that higher levels of education are linked to accessing better jobs, potentially leading to higher earnings as well as greater opportunities. Being out of school will have negative effects on a child's future. Parents play a critical role in encouraging and supporting their children's education.

Research confirms that there is a correlation between education and social cohesion. Schools help create a sense of belonging by fostering respect and equal treatment, thus contributing to a more cohesive society which embraces diverse groups.

## General Information on the Education System in Türkiye

In Türkiye, education is compulsory for 12 years and 4+4+4 education system is implemented (primary school: grades 1, 2, 3 and 4; lower secondary school: grades 5, 6, 7 and 8; and upper secondary school: grades 9, 10, 11 and 12) for school aged children. Children must be enrolled in formal education in Turkish public schools (TPS). Although non-formal and informal education are not alternatives to formal education, they can play a key role in supporting children's learning or preparation for/transition to formal education.

Parents are encouraged to contact school principals if they have concerns about the performance or well-being of their children. MoNE has provided many schools with training on inclusive education and continues to take measures to facilitate the smooth inclusion of Syrians UTP and other refugee children in the formal education system. In addition, MoNE has the responsibility and systems in place to ensure every child's well-being in school.

Pre-primary education is accessible for all children aged between 36 and 68 months. Starting to learn early supports all developmental areas of children and their readiness for primary school. Pre-primary learning is the foundation towards a child's successful completion of a full cycle of education.

Refugees of different nationalities other than Syrians UTP can also benefit from **free education services** in Türkiye.

## School Registration Process and Available Education Opportunities

#### (INFORM)

Registration in schools can take place starting from July. The parents need to visit the school before the start of the school year to complete the enrolment procedures. Children can be enrolled in school regardless of their ability to speak Turkish. TPSs have programs to support them with the Turkish language and homework. NGOs may also provide support during the registration process in their operating area upon request. 2025-2026 school year will start on Monday, Sept. 8, 2025. Open Lower Secondary School and Open Upper Secondary School registrations usually start in August and end in October. You can follow the announcements about the registrations at https://aio.meb.gov.tr/ and https://aol.meb.gov.tr/

#### e-Equivalence

When applying for the equivalence certificate, please note that it may take a few weeks for the submitted documents to be sent to Ankara and evaluated by the provincial or district national education directorate (P/DoNE), and documents that are not notarized may be considered as incomplete documents. To apply, you must follow the steps given below:

- 1. Go to the e-equivalency web page https://edenklik.meb.gov.tr/?culture=en-US which is available in Turkish, English, Arabic, German, French, Russian and Persian.
- 2. Follow the instructions on the web page and enter the required information.
- 3. At the end of the application the system will give the applicant an appointment (date and time) in a P/DDoNE that is closest to the given address.
- 4. Applicant then should be present for the given appointment time in order to receive his/her equivalency certificate. His/her documents will be evaluated until the appointment day and time and the applicant will be able to directly receive a certificate.
- 5. If the documents and/or the information was found to be insufficient by the equivalency commission, the commission may request further documents and/or information.

#### Preschool and Grade 1: (Primary School)

Children can attend preschool starting from the age of 36 months. At the age of 69 months (5.5 years old) children must be enrolled in Grade 1. 2025-2026 School Year school starting age is calculated as end of September (30/09/2025). 
When children reach compulsory school age, they should be automatically assigned to the nearest school by MoNE if Turkish family's address is recorded in Central Population Management System (MERNIS). To learn about the school to which the child has been assigned, the MoNE website https://e-okul.meb.gov.tr/ or the e-Devlet link https://www.turkiye.gov.tr/milli-egitim-ilkogretim-okullari-adrese-gore-kayit-okulu-sorgulama-e-kayit can be used. The families can also find out which school the child has been assigned to by enquiring at a local public school. They can speak to the assistant principal in charge of registrations.

If Syrians UTP and other refugee children are 57 months or older and cannot see the school assigned from the above links, they can apply to the nearest TPS for preschool or primary school registration. For school registration, Temporary Protection Identity Document (TPID), showing that the family is registered to that province, is requested. Address updates are made by Provincial Directorates of Migration Management (PDMM).

#### **Turkish National Education System**



#### **Grade 5 (Lower Secondary School):**

Students completing 4th grade in 2024-2025 school year will be assigned to the nearest lower secondary school to their addresses on MERNIS and should visit that school before the beginning of the schools. To learn about the school to which the child has been assigned and its contact information, the MoNE website https://e-okul.meb.gov.tr/ or the e-Devlet link https://www.turkiye.gov.tr/milli-egitim-ilkogretim-okullari-adrese-gore-kayit-okulu-sorgulama-e-kayit link can be used. The families can also find out which school the child has been assigned to by enquiring at a local public school. They can speak to the assistant principal in charge of registrations.

If the student wants to move to an imam hatip lower secondary school or a private school, it is required to visit the schools directly to register. Some schools can administer an exam to identify the students. Exam dates can be found on school websites.

#### Grade 9 (Upper Secondary School)

Transition to high schools is administered through central, local and boarding school placement. The central placement is carried out for schools (science high schools, social sciences high schools, Anatolian high schools, Anatolian imam hatip schools, project schools and vocational and technical Anatolian high schools' Anatolian technical programs) that accept students through central examination according to the central exam score superiority in line with choices. The local placement is carried out by provincial and district education directorates according to the type, quota and location of the schools in the secondary education registration areas in line with the criteria of the residence addresses of the students, the superiority of the school success score and the low number of absent days without excuse. Additionally, in order to provide comprehensive information to families, MoNE published the "Preference Process Parent Guide": https://meb.gov.tr/meb\_iys\_dosyalar/2025\_07/10100949\_Tercih\_Sureci\_Veli\_KYlavuzu.pdfThe school choices can be made by the student and their parents at https://e-okul.meb.gov.tr or from any secondary or imam hatip secondary schools. The choices must be approved by the school administration.

Aptitude Tests are held by schools for placement in science high schools that are project schools, fine arts high schools, sports high schools, and Anatolian imam-hatip high schools that implement music, hafiz, traditional and contemporary visual arts, sports programs/projects. Students who choose boarding schools and are not placed in any of their choices within the scope of local placement are placed in boarding schools, provided that it does not exceed the school's boarding quota (girls and/or boys) and the total vacant quota remaining after the local placement.

Positive Discrimination for Students Affected by the Earthquake: Students completed 2024-2025 school year in Adıyaman, Hatay, Kahramanmaras, Malatya and Gaziantep's Nurdagi and Islahiye districts and made choices for schools accepting students with central examination during the choice period will have an additional quota (1) for every 30 quotas. Placement procedures for additional quotas will be made according to the score superiority and choice priority within the framework of central placement rules. There will be no quotas during the first and second transfers and all other transfers afterwards.

#### **EBA** (Education Information Network)

EBA is an online education platform for students, teachers, and parents with specific features for each group. The system is designed to appeal to all students with different teaching methods such as verbal, numerical and visual. Educational content and materials produced by teachers can be shared with students. It also offers an interactive and social class/lesson environment with active participation.

For students, there are services like customized learning environments and interfaces according to the student, student-specific calendars, additional publications and resources, controlled games, access to all course content, repetition of lessons learned, question and exam banks, access to teacher support outside school.

For parents, the system provides an academic follow-up of the student, the opportunity to follow the exam dates and studies of the child, following the development of the child with the reports generated by the system and monitoring the performance of the child in school subjects.

Forteachers, the system access to all course content, content and question pools compatible with MoNE curriculum, special course content for interactive whiteboards, monitoring and supporting students, detailed development reports on the basis of a class and by student, directing students to specific needs. EBA provides services such as courses, programs, and a distance learning environment to develop professional knowledge and skills, as well as the ability to send assignments, activities, discussions and projects.

MoNE is delivering distance education by broadcasting lessons on TRT EBA channel for preschool, primary school, lower secondary school and high school students. To access the TRT EBA broadcasting; a cable/satellite TV or a private TV subscription is necessary. Every week, a weekly lesson schedule of courses published through the public TV https://www.trt.net.tr/yayin-akisi, EBA website https://www.eba.gov.tr/ and on social media https://x.com/trt\_ebatv for grades 1 to 12. Each course is 30-minute and covers the general TPS curriculum such as: Turkish, life sciences, social sciences, English, mathematics, science, history and physical education. TRT EBA lessons are broadcasted 24/7; including solutions to questions and lecturing for students preparing for high school and university entrance exams.

Access to EBA Online is only possible with an internet connection from the http://www.eba.gov. tr/#/anasayfa link. All students who are registered in the MoNE system have access to EBA Online. Students can enter the EBA system with their ID number and a password. All students have their own personalized page where they can track their lessons, homework and other activities.

#### **Vocational Education Centers**

Vocational Education Center (VEC) programmes are being delivered in all 81 provinces providing education in 39 areas in 193 branches. The theoretical training is given for 1 day a week at VECs while onthe-job training is provided for 4 days in a workplace environment.

The VEC programme can be implemented both in VECs and in Vocational and Technical Anatolian High Schools. VECs accept applications year-round.

Requirements for enrollment to VECs:

- ► At least graduation from lower secondary school (8th grade),
- At least 14 years old (no upper-age limit),
- Being healthy and psychically fit to accomplish the requirements of the selected vocation,
- Signing a contract with a workplace related to the profession to be registered (The workplace where the contract will be signed must have a master with a Master Trainer Certificate),
- ▶ For Syrians UTP: If 8th grade graduation is documented, they can be enrolled to the high school diploma programmes in VECs, if 8th grade graduation cannot be documented or proved, they can be enrolled to the VEC programme but will not be able to receive high school diploma, they would only receive mastership certificate and business license upon graduation.

VECs are a part of formal and compulsory education system in Türkiye and students can receive a high school diploma after completion. When graduated, they also receive technician title, mastership certificate, a business license to open their own workplaces and Europass Certificate in their field of mastership.

Students are insured by the VEC against occupational accidents and diseases during their apprenticeships. At grades 9, 10 and 11, VEC students receive an amount of at least 30% (at grade 12 at least 50%) of minimum wage.

#### **Transition to Higher Education**

In Türkiye, individuals under both international protection and temporary protection have the right to benefit from higher education. However, access to university requires taking an entrance exam. According to the Higher Education Council (YÖK) decision, starting from the year 2023, the application process for international students, including those under international and temporary protection taking university entrance exams is as follows:

- From the 2022-2023 academic year onwards, foreign students who will enroll in secondary education institutions (with some exceptions) are required to enter higher education institutions only through the Higher Education Institutions Exam (YKS). In this case, international students who enroll in the first year of secondary education institutions from the 2022-2023 academic year will take the YKS exam after graduating from high school.
- ▶ YÖK, in another decision, has decided that universities, as of the 2024-2025 academic year, should consider the results of the TR-YÖS (International Students Admission Exam), the high school grade averages determined by the university senate, and the results of their countries' own international exams for accepting international students. With this decision, YÖK decided to discontinue YÖS (Examination for Foreign Students) conducted by the universities.
- ▶ In accordance with these two decisions, students who enrolled in high school from the 2022-2023 academic year will take YKS, whereas other international students will take the TR-YÖS. TR-YÖS is a centralized exam administered by Student Selection and Placement Center (ÖSYM). High school students under international and temporary potection must regularly check ÖSYM's website (www.osym.gov.tr) for TR-YÖS dates. This exam is held twice a year in Turkish, German, Arabic, French, English, and Russian.

Free YKS preparatory courses are available at public education centers (PEC). Additionally, YKS modules are also available on the YTB Academy website of the Presidency for Turks Abroad and Related Communities (YTB): https://akademi.ytb.gov.tr/

In Türkiye, various institutions provide scholarships or financial support for university students under international and temporary protection. These organizations include the UNHCR, International Center for Migration Policy Development (ICMPD) and NGOs. Information about scholarship and financial support applications is announced through the institutions' websites and social media pages. #### **Conditional Cash Transfer for Education**

The Conditional Cash Transfer for Education (CCTE) programme is a national social assistance programme implemented by the Ministry of Family and Social Services (MoFSS) and Ministry of National Education (MoNE) since 2003, which was extended to Syrian and other refugee families with the support of the European Union (EU) in mid-2017. The CCTE programme is funded by EU and implemented through the cooperation of MoFSS, Türk Kızılay and MoNE. The programme aims to encourage enrolment and improve school attendance of children. The CCTE programme also includes important child protection component that will ensure the identification and assessment of the most vulnerable refugee children and their referral to complementary child protection services, as required.

Syrians and other refugee children who are enrolled in TPSs can benefit from the CCTE programme. CCTE offers cash assistance every two months to eligible families' KIZILAYKARTs if their children attend school regularly (at least 80% attendance in a school month). In addition to the transfers on the condition of regular attendance, school-beginning additional and motivational payments are also provided to all children enrolled in the programme at the start of each semester. The conditional payments are based on grade and gender, the higher grades and girls are paid higher amounts, whereas motivational payments are based on school level, the higher levels are paid higher amounts.

While the number of children benefiting from CCTE was 56,245 when the program started in May 2017, it reached 360,293 (52% and 48% boys) on 31.05.2025.

Applications for the CCTE Programme can be made through the Turkish Red Crescent Service Centers or Social Assistance and Solidarity Foundations (SASF) in the district where the family's official address is registered. #### **Other Assistances**

- ▶ A catch-up program is conducted for refugee students studying in grades 8, 11 and 12 for the classes they need academic support in 29 provinces (Adana, Adiyaman, Afyon, Ankara, Antalya, Batman, Bursa, Corum, Denizli, Diyarbakır, Eskisehir, Gaziantep, Hatay, Istanbul, Izmir, Kahramanmaras, Kayseri, Kilis, Kocaeli, Konya, Malatya, Mardin, Mersin, Nevsehir, Osmaniye, Sakarya, Samsun, Sanliurfa and Yalova) where Promoting Inclusive Education for Kids in the Turkish Education System (PIKTES+) project is implemented.
- ▶ School books are distributed free of charge by MoNE through schools at the beginning of the school year. Transportation to and from school is also provided by PIKTES+ and MoNE for Syrian and refugee children in some provinces. School principals and DDoNEs can provide information about schools with transportation services.
- Syrian and refugee students can benefit from catch-up lessons organized by many schools, NGOs and community centers during weekends. PECs and Yunus Emre Institutes (YEI) also offer Turkish language lessons upon request. You can find links to YEI's Turkish teaching portal and video lessons at https://yee.org.tr/tr
- ▶ Many TPSs organize free courses for students after school hours. The Support and Training Courses (STC) are offered during the academic year and summer holiday. You can find detailed information about STC and summer schools at https://e-kurs.meb.gov.tr/Dosya/2025\_2026\_DYK\_Kilavuzu.pdf
- Within the scope of PIKTES+, Turkish language remedial education is provided for refugee students studying in grades 3-12 to improve their Turkish reading, writing, listening and speaking skills and to compensate for their learning deficiencies. A Summer Term Catch-Up Program is carried out for out of school children or school aged children who have dropped out of school for several reasons within the scope of PIKTES+. The program aims to compensate for academic gaps of refugee children (Afghanistan, Palestine, Iraq, Somalia, Syria and Yemen) between the ages of 9-18 and include them in the education system. In addition, Turkish and Arabic courses are organized during the summer period by Turkish instructors to improve the students' language skills.
- Children with special educational needs can also be enrolled in schools and receive the guidance required to enable them to benefit from available education opportunities. Applications to the Guidance and Research Centers (RAM) in their district can be made by schools or parents. - ▶ Science and Art Centers (BİLSEM) provides support training out of school hours to enable students who attend formal education institutions and who are identified as having special talents in the field of general talent (mental), visual arts or music, to develop and use their talents at the highest level. BİLSEM students are selected by exam from 1st, 2nd and 3rd grade primary school students.
- ▶ Within the scope of PIKTES+ culture-independent diagnostic tests developed, appropriate educational environments and educational materials prepared, and in-kind support provided to special education schools for Turkish and refugee students with special needs who differ significantly from their peers in terms of their individual and developmental characteristics and educational qualifications in order to provide an occupation and prepare them for life.

## RECOMMENDED OUTREACH AND BACK TO SCHOOL SUPPORT ACTIVITIES

This section offers suggestions on the kinds of activities which organizations may wish to include as part of their BTS advocacy. These activities are based on discussions with organizations regularly attending the Education Sector Working Group and Child Protection Sub Sector meetings. They do not constitute a comprehensive list of all possible activities. They can be adapted in accordance with local context and organizations' capacity.

Planning a BTS activity can include the following elements:

Learn more about the local contexts in their respective locations

Disseminate information to the families of Syrian and other refugee children

Support families and children enroll in schools or benefit from other forms of education

## Update your information regarding school registration processes and education opportunities

- ▶ Visit the P/DDoNEs in your city of operation and obtain up-to-date information on the enrolment procedures that families must follow to enroll their children. Identify (and meet, if possible) focal points to be contacted regarding possible issues with enrolment.
- ▶ Find out what procedures should be followed for children who have never been to school or who do not have documentation showing previous school attendance.
- ▶ Ensure that you are familiar with the enrolment procedures followed for TPSs. Provincial procedures may vary, so make sure you are up to date! Check the documentation needed by refugees when enrolling their children in schools.
- Obtain (if relevant and feasible) copies of forms that parents will have to fill in and translate them into the languages spoken by refugees so that parents understand what information they are providing.
- ▶ Learn about other available education programs, such as VECs.
- ► (If feasible) Establish connections with TPSs in your area of operation to learn about their particular concerns, such as space limitations, any unique requirements, etc. to be able to refer children to these schools.
- Check the websites of MoNE, P/DDoNEs and nearby schools regularly to get up-to-date information. You can also follow them on the social media.

#### Host BTS information days in your offices/centers

- Organize 'information/awareness-raising' sessions in which you emphasize the children's right to education and provide concrete information about the procedures for enrolling children in schools.
- Provide information about available services, like PECs, Youth Centers or any programs provided by key stakeholders such as municipalities and NGOs in your area. For this, familiarize your staff with the available services.

- ▶ Display materials (posters, brochures, announcements) about available services or support programs such as CCTE, ESSN and others in your centers.
- Make the day fun for all by providing activities (e.g.: coloring competitions) for children who may be with their parents.
- If possible, print simple information sheets about the school registration procedures and provide these to parents, inviting them to further information sessions if needed.
- Share BTS messages on your social media accounts.

## Work with other teams to ensure that BTS activities are mainstreamed in your organization

- Hold a meeting with your colleagues and raise awareness on the importance of collaboration across different sectors/ actors to support school enrolment.
- Provide information on schooling opportunities for Syrian and refugee children and common challenges/barriers to access to education as well as recent figures.
- ▶ Ensure that BTS messages are incorporated into ongoing activities such as community outreach and general information sessions and refugee counselling provided by your organization.

## Provide practical support to families during the registration period

- If authorities require documents to enroll children in schools, you may work with local authorities to facilitate the issuing of these documents to families.
- ▶ It has been a practice among some NGOs to have staff or volunteers to accompany families to P/DDoNEs or schools to assist them by offering translation and explaining enrolment procedures requirements.
- ▶ If possible, transportation could be arranged for families from your centers to places where parents need to go to enroll their children or obtain necessary documentation.

## **Support the National BTS Communication Campaign**
